



Water Treatment Certification Review

Are you prepared for the November 15 test? Do you need contact hours?

California Rural Water Association (CRWA) is offering review classes designed to enhance your working knowledge of Water Treatment. The classes include a pre-test, detailed instruction on the expected range of knowledge for Water Treatment operators, and practice exams. This format helps operators brush up on the many aspects of Water Treatment systems and assists individuals with test taking skills. CRWA member registration is \$250, non-member registration is \$350.

Sign-in begins at 8:00 am. Class time is 8:15 am to 4:00 pm, with lunch (on your own) from 12:00 to 1:00 pm. There is no registration deadline for these courses. Attendees will earn 12 contact hours. **Please bring a calculator and pen to class.**

Did you know that Water Treatment and Distribution operators for systems serving a community or non-transient population of less than 3,300 (fewer than 1,000 connections) are eligible for expense reimbursement through a new state program funded by EPA?
